

HDP Pre-painted Steel Sheet Limited Warranty

The **Warranty** warrants the product described below with proper handling, storage, commissioning, maintenance and under normal circumstances, the performance can be maintained.

1. Top paint coating will remain adhere to the steel base (excluding any minor blisters at cut edges)
2. The top paint coating will provide an effective weather-resistant film.

The **Warranty** will be effective for a period of ☐ **HDP-15** years from the date of **delivery to site**.

ColourRun makes no guarantees, ether express or implied beyond the facts hereof: including without limitation, warranties of fitness for a specific application and merchantability and shall have no other liability with respect thereto.

This Warranty shall be subject to the stipulations, limitations and conditions hereinafter set forth:

1. The Warranty applies only to corrosion from the weather side and where more than 5% of the surface area of any one building is affected.
2. In the event of breach of this warranty, **ColourRun** shall have the option of replacing the defective sheets or furnishing sufficient sheet product to enable the Buyer to fabricate replacement sheets for the defective sheets, or by compensating the Buyer with due regard to the pro-rata of actual performance versus warranted performance based on the selling price. No liability shall be accepted for any consequential loss or damages attributable to the failure.
3. **ColourRun** shall not in any event be liable for the cost of labour expended by others on any non-conforming sheet or for any special, indirect or consequential damages to anyone by reason of the fact that such sheets shall have been non-conforming.
4. Claims must be promptly reported in writing to **ColourRun** and **ColourRun** shall be given a reasonable opportunity to inspect the sheet claimed to be non-conforming. Adequate identification of material involved in the claim, including but limited to the date of installation, **ColourRun**'s order number, coil number, invoice number and the date of finding must be established and provided by the Buyer.
5. This **Warranty** applies only to this pre-painted steel sheet product and not to any paint coating or other finishes that any be applied to the sheets.
6. The Buyer shall exercise due diligence in inspection of sheets as received from **ColourRun** so as to mitigate repair or replacement.
7. **ColourRun** extends this **Warranty** solely to the Buyer. This Warranty is non-transferable and non-assignable.
8. **ColourRun** reserves the right to terminate this warranty at any time (except as to orders already accepted) upon the giving of writing notice thereof.
9. This **Warranty** is intended by the parties to be a final, complete and exclusive statement of the agreement and is part of the contract for purchase of pre-painted steel sheet and any and all previous verbal or written statements are hereby excluded.
10. This limited warranty shall be governed by and interpreted in accordance with the Law of New Zealand.

This Warranty DOES NOT APPLY to sheets exposed under the Environment, including but not limited to:

1. ☐ **HDP**-Areas subject to salt-water marine atmosphere or to repeated spraying of either salt or fresh water.
2. Areas subject to fallout of or exposure to corrosive chemicals, ash, fumes, cement dust or animal waste.
3. Areas subject to water run-off from lead or copper flashing or areas in metallic contact with lead or copper.
4. Conditions or circumstances where corrective fumes or condensates are generated or released inside the building.
5. Contact with soil, fertilizers or other moisture retaining substance.
6. Storm and tempest or other Acts of God and force majeure.

This Warranty DOES NOT APPLY where:

Handling & Storage

1. Mechanical, chemical or other damage sustained during shipment, storage, fabrication, erection or during or after erection.
2. Failure to move debris form or provide free drainage of water, including internal condensation, from overlaps and all other surfaces of the sheets or sheets.
3. Deterioration of the sheets caused by contact with green or wet lumber or wet storage stain caused by water damage or condensation.
4. Presence of damp insulation or other corrective material in contact with close proximity to the sheets.
5. Deterioration to the sheets caused directly or indirectly by sheet contact with fasteners and sealants. (Suitable long lasting fasteners and sealant should be selected by the Buyer)
6. ☐ **HDP**- Severe marine, heavy industrial or corrosive environments.
7. Corrosion in cut surfaces and lead-ins of individual sheets where the metallic core of the sheet is exposed to the weather.

Commissioning

1. Damage caused to metallic coating by improper roll forming, sourcing or cleaning procedure.
2. Cutting sheet by circular saw or grinder as high temperature metal filings will damage the coating.
3. Failure to control the temperature in the range of 15~40°C when forming; while the finished pre-painted steel sheet are preserved constantly in the temperature higher than 80°C.
4. Failure to remove metal filings during construction and other debris daily in order to minimise risk of corrosion.

This Warranty DOES NOT APPLY where the Buyer DOES NOT comply with:

Maintenance Requirements

1. Surface of cladding must be washed every 3~6 months.
2. Gutters must be inspected and cleaned up every 6 months.
3. ☐ **HDP**- Areas sheltered from periodic washing by natural rainfall or man-made fresh water rinse on a regular 6 months basic.
4. Any noticeable build ups of salt or other contaminants must be removed immediately.
5. Please consult with your local distributor to ensure correct procedures are undertaken.
